SUMMARY:

On 06-21-99 , 1157hrs , several persons were arrested in front of KPFA Radio Station, the charges were for blocking entrance to a business. Victim/R.P. , Lynn Chadwick , made several citizen's arrest against several people that were protesting Ms Chadwick's decisions as station board-member. The protesters had decided to block the front-entrance to 1925 Martin Luther King Jr Way , Ms Chadwick's work building , and Ms Chadwick requested that they be removed.

Later in the day , around 1800hrs , I met with Ms Chadwick in one of her assigned offices. It was myself and Ms Chadwick. We were in the process of recording her statement when at least 25-30 people , later identified as people protesting against Ms Chadwick , charged into her office through the entry door. The people pushed their way in , bumping into each other , and started yelling at Ms Chadwick. I stood up and asked the people who they were and why they were in Ms Chadwick's office. The demonstrators ignored me but I knew they were there to confront Ms Chadwick about the arrest she had ordered. SEE ADDITIONAL-----

SUPPLEMENTAL CONTINUED:

The demonstrators had entered a private place of business. They had come pass a security door , walked up two flights of stairs, down a hallway and into the private office of Ms Chadwick.

The demonstrators never made any attempt to identify themselves. However , I recognized a number of them , mostly by face only. Two of the demonstrators were known to me by name , Maudelle SHIREK and Osha NEUMAN. Ms SHIREK is a Berkeley City Council member and Osha NEUMAN is an ex-Berkeley PRC commissioner.

The group filled the office completely up. There was hardly enough room to move. Ms Chadwick was blocked and couldn't exit. The group was yelling at Ms Chadwick and was thrusting microphones into her face. Ms Chadwick pleaded with the demonstrators to please leave her office and they refused. I asked the demonstrators to leave and they still refused. Ms Chadwick then broke down and started to cry.

I told the crowd that they would have to back off and that I was taking Ms Chadwick out and to another room. The group parted somewhat and allowed Ms Chadwick and myself to leave. The group then walked back outside the building and continued to demonstrate.

DISPOSITION:

It appeared to me that the demonstrators had come there to make a political statement. The local T.V. stations arrived just as I removed Ms Chadwick and seemed to know in-advance what was going on.

Ms Chadwick refused to file a complaint and I never made any attempt to question the demonstrators. Most of the demonstrators are still walking a picket line and ID can be made at anytime.
