NARRATIVE

CHADWICK CONTACTED BPD SEEKING ADVICE CONCERNING A GROUP OF DEMONSTRATORS OUTSIDE OF KPFA RADIO STATION AT ABOVE LOCATION. I ADVISED CHADWICK IF SHE WANTED THE BANNER REMOVED, SHE WOULD HAVE TO REMOVE THE BANNER HERSELF, BUT BPD WOULD DO A CIVIL STAND-BY TO ENSURE EVERYONES SAFETY.

I ALSO ADVISED CHADWICK IF SHE WANTED PEOPLE/ DEMONSTRATORS TO MOVE OUT OF THE DOORWAY ENTRANCE SHE WOULD HAVE TO REQUEST THEY MOVE & IF THEY REFUSED, SHE COULD PLACE THE DEMONSTRATORS UNDER CITIZENS ARREST & WE WOULD ACCEPT THE ARREST & REMOVE THE INDIVIDUALS.
