## DECLARATION OF DAVID ADELSON

- I, David Adelson, declare as follows:
- 1. I make this declaration in support of the Application for a Temporary Restraining Order and Order to Show Cause re Preliminary Injunction submitted by Plaintiffs The People of the State of California *ex rel*. Carol Spooner et al. I have personal knowledge of all of the facts contained in this declaration unless stated to be on information and belief. As to those statements alleged to be on information and belief, I believe them to be true. If called to testify, I would and could completely and truthfully testify as to the statements contained herein.
- 2. I am the Chair of the Local Advisory Board for Pacifica radio station KPFK in Los Angeles, California, and I have been the Chair at all times since December 1999. I have been a member of the KPFK Local Advisory at all times since at least September 1996.
- 3. At a meeting of the KPFK Local Advisory Board on May 4, 2000, the board by majority vote, 5 yes, 2 no, and 1 abstention, with the chair (myself) not casting a vote, voted to remove Robert Farrell from the office of Director of the Pacifica Foundation. Robert Farrell was originally elected to the office of Director for a three year term commencing February 1999 by a nomination and vote of a majority of the KPFK Local Advisory Board on October 29, 1998.
- 4. I personally notified via certified mail sent to the Pacifica Foundation (on May 19, 2000) and by email (on May 8, 2000) the Chair of the Pacifica Board, Mary Frances Berry, the vice-chair, Mr. David Acosta, the Executive Director, Ms. Bessie Wash, and Mr. Farrell of the KPFK board vote to remove Mr. Farrell from office, however he has refused to vacate the office and continues to act as a director of the Pacifica Foundation.
