Andrea Cisco and Frank Millspaugh were originally elected to their offices as Directors by nomination and vote of a majority of the WBAI Local Advisory Board for three-year terms commencing March 1998.

On information and belief the Chair of the WBAI Local Advisory Board Joanne Bobb notified the then Chair of the Pacifica Board of Directors, Mary Frances Berry, and Ms. Cisco and Mr. Millspaugh of the vote to remove Ms. Cisco and Mr. Millspaugh from office, however they have refused to vacate the office and continue to act as a directors of the Pacifica Foundation.
